Louth endoscopy unit recognised for excellence

Our endoscopy unit at County Hospital, Louth has recently been given Joint Advisory Group accreditation. Known as JAG, this is a national award set up to ensure high standards of care in clinical quality, quality of patient experience, training and workforce.



The endoscopy unit moved into a refurbished area in April 2012. This new improved environment means patients move in a circle from waiting room, to preparation

rooms, to the endoscopy room itself. There are also new dedicated waiting, admission and discharge rooms along with single sex accommodation and a state of the art decontamination area.

Work has been done to improve the equipment and paperwork to ensure the new unit meets the highest possible standards, and a visit by the Joint Advisory Group on gastrointestinal endoscopy last month secured its accreditation.

Trust performance—December 2015

The Trust did not achieve the 4 hour waiting time target in A&E in December 2015 (84.88%)

The 18 week referral to treatment incomplete target was achieved in December 2015 (92.40%)

8 out of the 9 cancer targets were achieved in November 2015

The Trust has had 1 case of MRSA during 2015/16 to date.

The latest mortality position is 101.69 for Sep 2014 – Aug 2015 (HSMR)

The next public Trust Board meeting is on Tuesday 2 February 2016 in Committee Room at Pilgrim Hospital (Education Centre).

Visitors still being advised to stay away from Lincolnshire's hospitals.

The norovirus outbreak at Lincoln County Hospital has now been officially declared as over.

Although the outbreak is now over, norovirus continues to circulate in the community and the hospital is still experiencing a number of cases of patients admitted to the hospital who are incubating the infection.

Michelle Rhodes, Director of Nursing said: "It is testament to the hard work and dedication of our staff that we are able to declare this outbreak over."

"I'd like to thank the public too. In staying away from our wards and A&E they have helped us cope and keep disruptions to a minimum. But we still need their support. Visiting restrictions remain in place in order to limit the spread of the virus and to protect our vulnerable patients and our staff."

The number of visitors per patient will be limited to a maximum of two per bed space, in all but exceptional circumstances. Children aged 5 years and under should not visit the hospital.

If you have norovirus symptoms or have had them in the past 72 hours, please do not attend A&E or visit the hospital.

Members survey

A massive thank you to everyone who participated in our first survey, sent in November 2015. We have received very constructive feedback and ideas, which we are looking to take forward. The survey was completed by 221 members, which gives about 20% response rate. Amongst many comments, we identified common themes on how to improve the newsletter, AGM and locality forums. The main points to take forward are:

- Newsletter needs to include more balanced news (positive and negative stories), more data on performance and update on action log (questions raised by members during locality forums)
- AGM needs to be interactive, with less presentations and more interesting agenda, organised at accessible venue
- Locality forums could allow more time for Q&As, involve members in creating agenda and organised in current setting (quarterly across all sites).

What we've been doing

When members take part in patient representative activities, they are required to fill out forms to log attendance and feedback contribution and questions, here are some of the points members wanted to feed back in the past month:

To all trained members— Reporting forms do not need to filled out for attendance at locality forums or pathway review visits, but forms are required ro any activity you wish to claim expenses for.

Attendance at outpatient transformation group by Roger Thorley January 2016

 Meeting reported a high number of overdue outpatient appointments on the new booking system. Update will be given at the next meeting in February.

Attendance at patient experience committee by Michael Cassidy in January 2016

- Digby Ward— complaints reduced due to new outlook on patient experience - encouraging open communication between staff, patients and visitors
- Volunteers—database not up to date, potential to play larger role within the Trust, more support for volunteers needed
