New roles volunteers support the Accident and Emergency department Pilgrim Hospital, Boston are now available.



Lauren Wignell, A&E Performance Manager said: "This is a really exciting opportunity for anyone interested in supporting our fabulous A&E staff. We haven't had volunteer roles within the department for a number of years so we're thrilled to be able to welcome volunteers back."

The duties of the volunteers in A&E will include welcoming patients and visitors to the department, providing information to patients such as waiting times and escorting patients to main reception or the discharge lounge. Other duties include sitting and chatting with patients and relatives, assisting with meals and drinks, general tidying and supporting those patients and relatives with dementia.

What we've been doing

We would like to kindly remind our active members that when taking part in patient representative activities, they are asked to fill out forms to log attendance and feedback their contributions and questions. We find this feedback very useful and would like to share their input with the wider membership audience.

Trust performance - February 2017

- We have a target that 95% of patients visiting A&E should be seen and either treated, admitted
 or discharged within four hours. For the month of February our performance was 75.22%.
- We have a target to have seen 92% of patients within 18 weeks of a GP referral, and during February 2017 our performance was 88.27%.
- We achieved three out of the nine cancer targets set for us.
- Our latest hospital standardised mortality (HSMR) performance, for June 2015 to May 2016, is 101.76. This is within expected levels.
