

Trust performance - October 2016

- Four hour waiting time in A&E performance was 81.28% against a target of 95% - an improvement from September
- The 18 week referral to treatment incomplete target was missed - 87.74% against a target of 92%
- Six out of the nine cancer targets were achieved in September 2016
- The latest mortality position is 101.76 for June 2015 –
 May 2016 (HSMR), which is in the expected range.

Lincoln County Hospital ward recognised for support of carers

Clayton ward at Lincoln County Hospital is the first ward at United Lincolnshire Hospitals NHS Trust to be presented with Lincolnshire Carers Quality Award.

The award, presented by Every-One, is given to health and social care departments who have been proven to recognise the importance of carers in supporting their patients.

Clayton ward has been recognised following letters and cards from carers who found the team were supportive whilst their relative was on the ward and because they offer information about open visiting times for carers, free car parking and support for staff who are carers.

Averil Adams, acting ward sister on Clayton ward said: "I'm very proud of the team for being the first ward at ULHT to

achieve the Lincolnshire Carers Quality Award. It gave us the opportunity to demonstrate the support we give to carers on Clayton ward; whether they are a patient who is a carer, a patient who has a carer or a member of staff with caring responsibilities.

"We attended carer awareness training and produced a portfolio of evidence to demonstrate the measures we take to support carers on the ward, and found it an interesting and rewarding experience."



Hospitals improving care for patients at the end of life

Ward staff in Lincolnshire hospitals are receiving specialist training in caring for patients needing palliative or end of life care, as part of a new commitment to improving care for these patients.

United Lincolnshire Hospitals
NHS Trust together with St Barnabas Hospice has recently appointed a new team to focus on palliative and end of life care.

A new matron and two end of life coordinators are working to ensure patients at the end of life are involved in decisions about their care and given access to the best possible care, in the right place for them.

Matron Kerry Bareham has been joined by the end of life coordinators to work across Lincolnshire's hospitals, delivering training to staff on the wards to improve the care of end of life and palliative patients.

Grantham endoscopy unit recognised for excellence

The endoscopy unit at Grantham and District Hospital run by United Lincolnshire Hospitals NHS Trust has recently been given Joint Advisory Group accreditation.

Known as JAG, this is a national award set up to ensure high standards of care in clinical quality, quality of patient experience, training and workforce.

The unit cares for patients undergoing endoscopy procedures, which are procedures that are used to assess areas inside the body by inserting a flexible tube that can provide images of the area in question and be used to take samples.

This now means that all four units in Lincolnshire have received their accreditation.

Work has been done to improve the single sex areas, privacy and dignity and the decontamination facilities.
