For the period of the self certification the Trust has remained in special measures for Quality and Finance. The Trust has been supported by NHSE/ with an Improvement Director. Since the latest CQC inspection the Trust remains subject to conditions on its registration having been issued with a Section 29A warning Notice and Section 31 Decision Notice.

The Trust has taken steps to comply with the conditions. The Trust has developed action plans to address the matters raised by the CQC and the Board made improvements to the Strategic Risk Register and BAF during 2019/20. The Annual Governance Statement and Head of Internal Audit opinion reflect the outstanding issues and the Trust recognises that it is unable to confirm against the declaration following the Inspection by the CQC during 2019 which resulted in the Trust remaining rated as requires improvement and in special measures and the continued inconsistent performance against the constitutional standards.
